

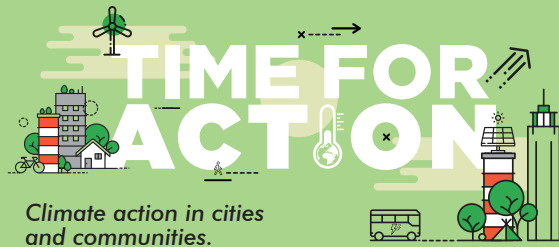

THE NEXUS WITH CLIMATE CHANGE

Climate change is one of the most significant and fastest growing threats to communities and cities, their natural and cultural heritage worldwide. If our common heritage is destroyed or lost, it may be impossible to replace or rebuild it. Historical and cultural sites in cities represent icons of human civilization and have a high intangible value

that needs to be protected against the impacts of climate change. At the same time, traditional knowledge may hold some of the solutions for effective climate action.

The time for action is **NOW**.

PROTECT historical and cultural sites from climate change

- Impacts of climate change threaten many vulnerable areas worldwide such as flooding or sea level rise.
- Both natural and man-made heritage sites are in danger of being fundamentally altered, damaged or destroyed.
- We need adaptive solutions to protect our urban heritage and make it resilient to extreme climate events.
- Leave no one behind! Poor people, living in informal areas are often the most vulnerable to the impacts of climate change.



RESTORE ecosystems that are crucial elements of our urban heritage

- Reconcile nature with urban culture by increasing the footprint of nature in cities.
- Promote nature-based solutions in local and national action plans.
- Engage communities in green initiatives and activities, such as developing an urban gardening network.



PLAN resilient cities and communities

- Plan resilient cities adopting green-blue network approaches.
- Promote innovative and sustainable solutions in architecture and urban planning.
- Adopt sustainable mobility and transport solutions (e.g. promote public transport development, electric vehicles).



THRIVE through low carbon innovations integrating traditional knowledge

- Apply low carbon technologies in restoring iconic urban heritage.
- Apply the knowledge of local communities in resilience building, ensure their participation in decision-making.
